Local Control and Accountability Plan and Annual Update Template

The Local Control and Accountability Plan (LCAP) and Annual Update Template shall be used to provide details regarding local educational agencies' (LEAs) actions and expenditures to support pupil outcomes and overall performance pursuant to Education Code sections 52060, 52066, 47605, 47605.5, and 47606.5. The LCAP and Annual Update Template must be completed by all LEAs each year.

For county offices of education, pursuant to Education Code section 52066, the LCAP must describe, for each county office of education-operated school and program, goals and specific actions to achieve those goals for all pupils and each subgroup of pupils identified in Education Code section 52052, including pupils with disabilities, who are funded through the county office of education Local Control Funding Formula as identified in Education Code section 2574 (pupils attending juvenile court schools, on probation or parole, or mandatorily expelled) for each of the state priorities and any locally identified priorities. School districts and county offices of education may additionally coordinate and describe in their LCAPs services provided to pupils funded by a school district but attending county-operated schools and programs, including special education programs.

Charter schools, pursuant to Education Code sections 47605, 47605.5, and 47606.5, must describe goals and specific actions to achieve those goals for all pupils and each subgroup of pupils identified in Education Code section 52052, including pupils with disabilities, for each of the state priorities as applicable and any locally identified priorities. For charter schools, the inclusion and description of goals for state priorities in the LCAP may be modified to meet the grade levels served and the nature of the programs provided, including modifications to reflect only the statutory requirements explicitly applicable to charter schools in the Education Code.

The LCAP is intended to be a comprehensive planning tool. Course access: *pupil enrollment in a broad course of study that includes all of the subject areas described in Education Code section 51210 and subdivisions (a) to (i), inclusive, of Section 51220, as applicable. (Priority 7)*

Expelled pupils (for county offices of education only): *coordination of instruction of expelled pupils pursuant to Education Code section 48926. (Priority 9)*

Foster youth (for county offices of education only): *coordination of services, including working with the county child welfare agency to share information, responding to the needs of the juvenile court system, and ensuring transfer of health and education records. (Priority 10)*

B. Pupil Outcomes:

Pupil achievement: performance on standardized tests, score on Academic Performance Index, share of pupils that are college and career ready, share of English learners that become English proficient, English learner reclassification rate, share of pupils that pass Advanced Placement exams with 3 or higher, share of pupils determined prepared for college by the Early Assessment Program. (Priority 4)

Other pupil outcomes: pupil outcomes in the subject areas described in Education Code section 51210 and subdivisions (a) to (i), inclusive, of Education Code section 51220, as applicable. (Priority 8)

C. Engagement:

Parental involvement: efforts to seek parent input in decision making at the district and each schoolsite, promotion of parent participation in programs for unduplicated pupils and special need subgroups. (Priority 3)

Pupil engagement: school attendance rates, chronic absenteeism rates, middle school dropout rates, high school dropout rates, high school graduations rates. (Priority 5)

School climate: pupil suspension rates, pupil expulsion rates, other local measures including surveys of pupils, parents and teachers on the sense of safety and school connectedness. (Priority 6)

b. Stakeholder #2—school personnel

Throughout the entire year extensive professional development training was provided, and collaborative principal/teacher briefings were conducted to monitor review and evaluate faculty mastering of common core central concepts and how they should be applied.

CAL used the following quantitative data to structure the goal setting process:

1. Attendance rates
2. Student programs
3. Instructional materials
4. Facility Inspection Data
5. CCSS/SBAC-ELA proficiency rate
6. CCSS/SBAC math proficiency rate
7. English Learner reclassification rate
8. LAUSD site review data

After full compilation and through calculation of all relevant quantitative areas of interest, the CAL LCAP team was able to identify key areas of strengths, weaknesses, and areas where new goals needed to be set.

c. Stakeholders #3—Parents

Parent participation was organized and recorded by monthly logs that were collected at monthly meetings. Monthly parent academic initiative meetings were held and data was collected as to the number of parents attending per month. Parents were informed regarding the goals set for the students via monthly ‘coffee with the principal’ meetings and an annual survey.

As part of the outreach strategy an online survey was developed which attempted to capture and assess the degree of interest and parental involvement in the CAL learning process. This information was also used to determine from a parental perspective if we needed to change our goals to meet parental expectations.

d. Stakeholders #4—The Community

The CAL LCAP community made concerted efforts to consult with a variety of community organizations. Most notable among that group has been the involvement of the Los Angeles Police Department—

known to our staff and school.

As a result of the collaborative process of gathering input from our stakeholders, CAL developed a “New List” of Goals and Priorities that has captured our focus and require immediate attention: New concerns could include:

- Expansion and development of a middle school.
- Insight about available resources in the community.
- Exploring new ways to expand student aspirations.

A site audit was conducted by Los Angeles Unified School District (authorizer) revealed new areas for improvement; as a result, these new areas have been targeted as our new goals.</p> <p>Quantitative and qualitative data was examined which indicated that there is still much progress that must be made in the following areas:</p> <ul style="list-style-type: none"> • Language Arts • Math • Closing the Achievement Gap • Special Education <p>The differences between budgeted expenditures and actual annual expenditures were noted and adjustments will be made for the coming years.</p> <p>Many of the budgeted expenditures may be adjusted downward due to the inexperience of making projections. Technology costs however soared upward and exceeded budgeted projections. This too was due to the inexperience of estimating what the total costs would be.</p>
